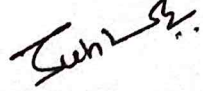
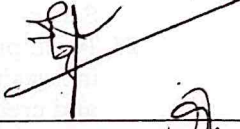

- b) Contributions and donations, deposits dedicated for a particular purpose with in the aims and objectives of the trust and other types of contributions, donations and kind of financial assistance rendered by religious, charitable, social and economic organisations.
- c) Interest and other sums received by trust.
- d) Contributions, donations, endowments and such other types of funds given, contributed and donated by individuals, bodies, associations, companies, Organisations, devotees and the public at large.
- e) Properties, movable or immovable, acquired by the trust by transfer, taking over, assignment, purchase, gift, donations, entrustment, lease or any other type of contributions and in favor of the trust.
- f) Income of the organisations, run and managed by the Trust, by way of contributions, donations, fees and other like income.
- g) The trust is at liberty to borrow loans from any persons either individual or corporate bodies or any other body, under any type of contract, subject to the decision of the Board of Trustees for due and efficient implementation of the aims and objectives of the trust.
- h) Family future contributions, towards Trust.

BOARD OF TRUSTEES :-

- a. The Board of Trustees shall ordinarily consist of not less than three and not more than nine members. The Trustees may Co opt to the Board of Trustees, if necessary, by mutual agreement of all the Trustees.
- b. The Board of Trustees shall be Trustees for Life (unless they Resign). The Trustees, whose term of office expires after the period of 5 years, are eligible to be Co-opted as Board of Trustees again by the existing Trustees. The Managing Trustees may if he/she so desires, resign his/her Board of Trusteeship even before the expiry of the terms of his/her Board of Trusteeship.
- c. The Trustees have a power to include the trustees or remove the existing trustees after getting of 2/3rd majority .
- d. Subject to the provisions hereinafter contained, the Trust shall vest in and be administered by a Board of Trustees consisting of One Chairman, One Secretary, and one Treasurer and Three Board of Trustees.

The Managing trustee / Secretary shall have the Custody of all documents, Deeds of Title relating to the trust properties and investments and the books of accounts and other records relating to the trust and shall be responsible for the preservation and production for free access of all the records and books, at all reasonable time.

40.ADVISORY BODY:

The Trustees may form an advisory board for the purpose of utilizing their services in furtherance of the objects of the trust.

41.IRREVOCABILITY :

- If the Trust fails for any reason, in the opinion of the trustees, the Net Assets and Liabilities of the Trust both moveable and immovable shall be handed over to any other Trust having the same objectives as decided by the majority of the trustees.
- In case of death, inability; resignation, Removal or refusal on the part of any trustees to act as such, the remaining trustees shall be entitled to nominate any other person as they may think fit and proper to act as trustee in place of the trustee so deceased, refusing to act or being unable to act. The Trustees so appointed will have the same powers and rights as if he/she was the originally appointed trustee under the presents.

42.RULES and REGULATIONS:

PROVISION:-

- The Board of Trustees shall be entitled to frame Rules and Regulations for the conduct of the affairs of the Trust and to carry out its objects, maintenance and conduct of its projects its activities and facilities provided therein and to alter, amend or any such rules and regulations from time to time as may be deemed proper. Such rules and regulations o be formed/framed shall not be in contravention to the provisions of the Income Tax Act of 1961 namely Section 2 (15), 11, 12, 13 and 80G further no amendments shall be made without prior approval of the Commissioner of Income Tax. The trust shall be registered under various Acts in force or Reamed in Future, as the case may be applicable from time to time.
